### Our LL.M. Program “Intellectual Property and Competition Law”

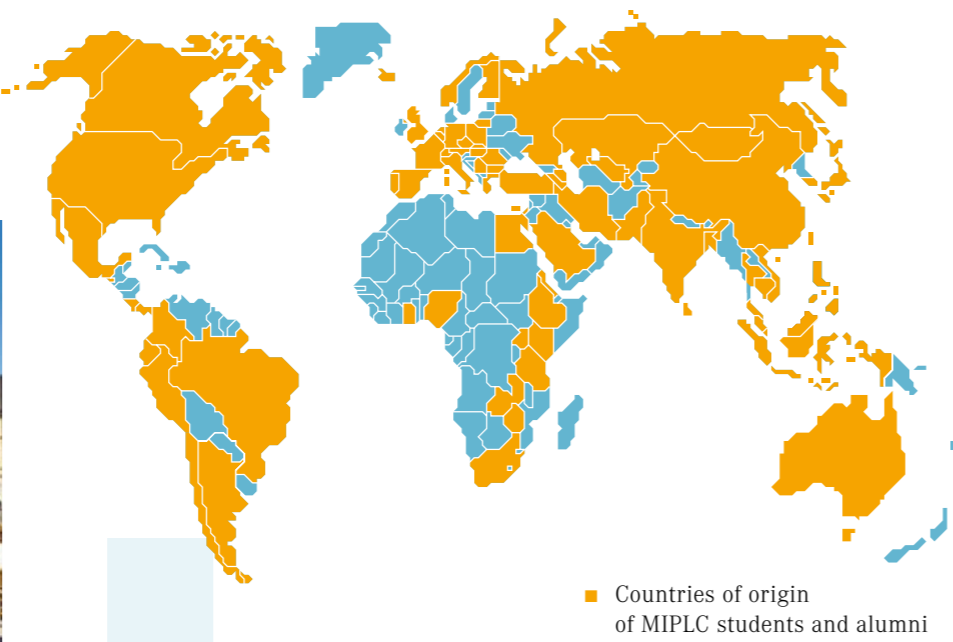
The MIPLC offers an international and interdisciplinary, one-year, English-language LL.M. program designed for participants from a wide variety of educational, professional, and national backgrounds. Taught to a maximum of 38 students per year, the program equips its graduates with the skills and knowledge necessary to handle complex intellectual property issues in a global context.

The teaching method at the MIPLC is focused on case studies, problem-solving, and the practical application of knowledge, with special emphasis on research, litigation, and negotiation skills. Students can test and practice their skills in simulated court cases and workshops or during an optional internship.

To support their studies, students are provided with individual work spaces in shared offices, including access to legal databases and to the Max Planck Institute’s IP library holding more than 200,000 volumes. They also benefit from individual and group tutorial sessions.

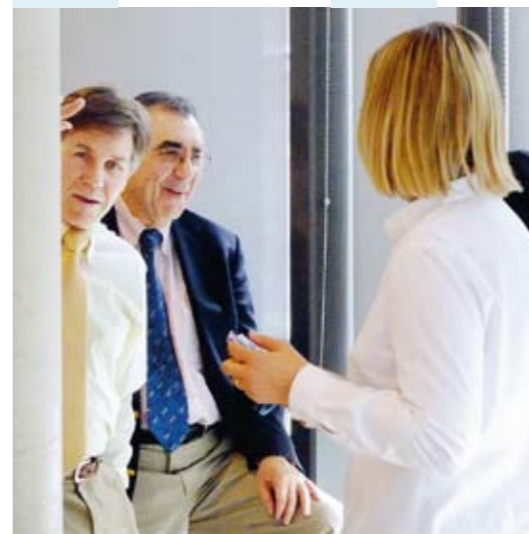

### Our Tutors

For the duration of their studies, our students are matched with a personal tutor with whom they can discuss course content and prepare for exams. Our tutors, many of whom are MIPLC graduates, are usually researchers or Ph.D. students at the Max Planck Institute, or young attorneys. Many of them have been supporting our students for several years.

Each tutor usually mentors two or three students, so tutorials can be held individually or in small groups.

### Our Administrative Team

All MIPLC affairs are managed by a small and dedicated team consisting of program and administrative staff. The Program Directors provide individualized academic counselling, e.g. regarding course selection and the Master’s thesis, while the Administrative Directors and Assistants are the main point of contact for all students throughout the academic year for a host of other issues. The administrative offices are on the same floor as the student offices, guaranteeing quick access and easy interaction.

### Our Students

The MIPLC is proud of its highly diverse student body. Every year, our students come from more than a dozen different nations and from a variety of professional and educational backgrounds, including lawyers, patent agents, judges, scientists, engineers, journalists, and many more. We have welcomed LL.M. candidates aged 22 to 55.

Class discussions benefit from such heterogeneity, and our graduates have formed world-spanning professional and personal networks.



**Admission Requirements**

1. A Bachelor's Degree (or equivalent). While most of our students hold a previous degree in law, natural sciences, or engineering, we also welcome students from other disciplines.
  2. At least one year of professional experience acquired after the first university or college degree.
  3. Very good knowledge of English, demonstrated by a TOEFL score of minimum 85 (internet-based), 223 (computer-based), or 563 (paper-based); or an IELTS score of 6.5 or above; or a minimum grade of "C" on the Cambridge CPE.
- The intake is limited to 38 students per year. The tuition fee for the entire year of studies is 32,000 Euros.

**Career Opportunities**

MIPLC graduates enjoy excellent career opportunities with a wide range of potential employers. Our alumni have embarked on ambitious careers as IP litigation attorneys or patent attorneys in major law firms; as IP officials for EPO, OHIM, or WIPO; or as legal officers or IP managers in private industry. Others are pursuing Ph.D. degrees at top universities.

The more than 300 members of the MIPLC Alumni Network form a close-knit community eager to counsel students, offer internships, and assist each other professionally.
