Course Details

Course organisation

The first five months of the programme comprise mandatory core modules that provide a solid foundation in basic management concepts and core organisational functions.

The core modules are followed by advanced courses that provide deeper insights on strategy and organisation, marketing and sales, entrepreneurship and innovation, and advanced finance.

The MBA programme includes three study-abroad weeks in the US, Asia and Middle East. The Asia and Middle East modules focus on the chances, challenges, and risks of doing business in emerging markets. The US module is a tailor-made executive education programme that provides insights into management education's latest hot topics.

The final MBA project can take the form of a business-plan, research paper, or report written in cooperation with a company while completing an internship.

We currently cooperate with partner universities in the USA (Kellogg, Chicago) and partner schools in Thailand, Vietnam, Israel and the United Arab Emirates. One week at each of the three partner universities is mandatory and consists of tailor-made lectures delivered by senior faculty members of our partners and company visits.

Integrated internships

The final MBA project gives you the opportunity to apply all that you have learned in a real-life project. We encourage our students to complete their Master's theses as part of a company project (internship).

Requirements / Registration

Academic admission requirements

We require the following for your application to the full-time MBA programme:

- a first degree (Bachelor's or equivalent)
- two years of postgraduate work experience
- one letter of recommendation from a former or current supervisor or professor
- TOEFL or IELTS if English is not your native language
- GMAT score or similar

Language requirements

As the teaching language is English, non-native speakers have to take the TOEFL (100) or IELTS (7.0) test. Waivers are possible for applicants with substantial study or work experience in the English language.

Non-EU applicants: 15 December (April intake) and 31 May (September intake)
EU applicants: 29 February (April intake) and 15 July (September intake)

WHU - Otto Beisheim School of Management

WHU - Otto Beisheim School of Management is a state-approved private institute of higher education with university status. WHU offers internationally-oriented courses of study in Business Administration (MSc, BSc), a full-time and part-time MBA, the Kellogg-WHU Executive MBA, and a doctoral degree programme as well as specialised corporate training programmes.

WHU also has the authority to award PhDs and professorships. Its international network includes more than 200 partner universities on all continents with whom exchanges of lecturers and students take place, as well as cooperation in research worldwide. In 1998, WHU became the first German university to be accredited by the European Quality Improvement System (EQUIS). In February 2014, the accreditation was extended by EQUIS for another five years. WHU is regularly certified by EQUIS and FIBAA and received the AACSB Accreditation in 2010, which guarantees the excellent standard of courses and a high degree of internationalisation.

In addition, WHU is the only private institution of higher education in Germany that is a member of the German Research Association (DFG). In both national and international rankings WHU - Otto Beisheim School of Management continues to occupy leading positions.

Düsseldorf is the capital of the state of North Rhine-Westphalia and is a city with many different faces.
