You will focus on theoretical principles, learn about state-of-the-art research and use methods to do your own innovative economic research. |

with the advanced analytical focus of your MSc.

Some examples of the questions that the Economic Research students look at include the following:

- What is the scope of behavioural interventions for public policy objectives? For instance, what is the role of environmental taxes, tradable emission certificates and nudges in addressing climate change?
- What are effective ways of measuring and regulating systemic risk in financial markets?
 What is the role of monetary policy for the stability of financial markets?
- What are causes of persistent economic inequalities? What policies foster social mobility?
 Why does inequality persist in modern welfare states?

All specialised courses of the programme relate to up-to-date research areas of our large research centres at the University of Cologne and Key Research Initiatives of the Faculty of Management, Economics and Social Sciences: the Cluster of Excellence ECONtribute: Markets & Public Policy The Center for Social and Economic Behaviour (C-SEB) and the Key Research Initiative Behavioural Management Science (BMS).

Become part of this network and explore research close at hand with renowned scientists. Research Master's students are highly welcome to take part in lectures, seminars, workshops and events of our local expert networks. We further offer workspaces and IT facilities at the research centres that are exclusively available for MSc Economic Research students.

Course Details

Course organisation

The Master's programme contains 120 ECTS credits and comprises a core section, a specialisation section, a supplementary section and a Master's thesis. The core section of the Master's programme in Economic Research contains 36 ECTS credit points. This area covers the advanced and research-oriented basis of micro- and macroeconomics, statistics, econometrics and mathematics. You will be enabled to handle scientific literature in economic science and analyse economic problems on an advanced theoretical and empirical level. In the specialisation section, you will choose six specialisation courses in the research area you want to focus on in your proceeding studies. You can also broaden your general knowledge by choosing from core courses you did not attend in the core section before. Two reading groups in micro-, macroeconomics or econometrics are compulsory. In these reading groups, students read and discuss the latest research papers in the respective research area. The supplementary section serves as an additional section to further develop a more specific profile – either by deepening and specialising or by diversifying knowledge.

After successful completion of stage one of the programme, you will have two options:

- Continue with the second stage of the graduate programme and start your PhD straight away (dissertation phase).
- Finish the programme with the Master of Science in Economic Research and leave as a highly qualified candidate for top positions in leading institutions and companies.

Requirements / Registration

Academic admission requirements

Bachelor's degree

Application in the case of unfinished Bachelor's studies: In cases where present Bachelor's studies have not been fully completed, application is permitted if the candidate has earned at least 80% of the required credits and will have achieved the remaining results by 30 September at the latest. The specific admission criteria governing the designated course of study (including the overall grade) must already have been fulfilled on the basis of the exam results available at the time of application.

Overall grade of at least 2.5 (German grade) in the Bachelor's degree

Fulfilment of the following subject-related requirements:

- 1. at least 36 ECTS in the fields of business administration and/or economics from this 18 ECTS in the field of economics
- 2. at least 15 ECTS in the fields of statistics and/or mathematics and/or econometrics (methodological courses only, no user expertise)
