Languages	Students can complete the whole programme in English. All mandatory courses are held in English. Mandatory electives and elective modules are offered in English and German at WFI, in English at RBS and in English and French at TBS. Participants can choose to write the Master's thesis in either English or German.

Description/content	<p>For this specialisation in our Master's programme in Business Administration, two specific double degree Master's programmes in International Business Administration have been developed, in which students have the opportunity to receive the Master of Science (MSc in Business Administration) academic degree from the KU's Ingolstadt School of Management (WFI) and a postgraduate degree conferred by Toulouse Business School (TBS) or Rajagiri Business School (RBS) respectively.</p> <p>Students are educated to fulfil management and specialist tasks in a national and international environment in a responsible, socially and professionally competent manner. In addition, students develop an understanding of other cultures and intercultural issues and contexts.</p> <p>Two of the four semesters are spent at KU's Ingolstadt School of Management (WFI), and the other</p>

two are spent in either France (Toulouse Business School) or Spain (Toulouse Business School) or at the Rajagiri Business School in India.

In Ingolstadt, students choose modules from the following areas of specialisation:

- Market-Oriented Corporate Management
- Finance, Accounting, Controlling and Taxation
- Entrepreneurship and Innovation
- Business Analytics & Operations Research
- Digital Customer Experience & Service Design

At the partner university, students must complete at least 30 ECTS credits in two trimesters. These can be obtained by taking modules in two specialisations. These include Marketing, Finance, Business Intelligence, Operations and HR.

The Master's thesis is supervised by representatives of the respective universities. Specific regulations may apply depending on the chosen partner university.

Course Details

Course organisation

The programme includes mandatory modules, mandatory electives, and elective modules. The six required modules can be chosen from the mandatory modules of the following other specialisations of the Master's programme in Business Administration: Market-Oriented Corporate Management; Finance, Accounting, Controlling and Taxation; Entrepreneurship & Innovation; Business Analytics & Operations Research; and Digital Customer Experience & Service Design; including one module in ethics. They are offered during the first two semesters in addition to six elective modules that need to be chosen from the list of elective modules in the five areas of specialisation mentioned.

After the students have completed the first two semesters, they take their elective modules at the partner university. At Rajagiri Business School, they can choose freely from all Master's-level modules covered under the cooperation agreement before writing their Master's thesis. At TBS, students can choose among a wide range of specialisations ("Professional Expertise") and will study in Toulouse, Paris, or Barcelona, depending on their elected field. In addition to the Professional Expertise courses, the programme consists of a TOEIC test in English, a soft skills certificate, a consulting mission, an internship, and a Master's thesis.

All required courses are taught completely in English. In the required electives and elective modules, students can choose modules in German or English. Moreover, some of the Professional Expertise tracks are bilingual, with courses in English and French.

The cost of living might be lower in Eichstätt and higher in Ingolstadt, depending on the accommodation (e.g. in a student residence or from a private landlord).

Description of the above-mentioned funding opportunities within the university	<p>The KU offers a scholarship (450 EUR per month) to academically qualified international students in financial need. This is funded by the Bavarian State Ministry of Science and the Arts through the "Förderung der Internationalisierung" programme. Scholarships are awarded for a period of five months. There is no automatic extension, but it is possible to reapply.</p> <p>Please find more information on financial issues, scholarships, and prerequisites on our website.</p>

Requirements / Registration

Academic admission requirements	<p>Prerequisites</p> <p>Academic admission requirements include a first qualifying degree in the field of business studies, business administration, economics or a very similar field obtained at a university in Germany or abroad. Applicants to this specification should be aware that the programme includes a mandatory stay of study either at the Toulouse Business School (France) or the Rajagiri Business School (India).</p> <p>Applicants who have obtained their first university degree (Bachelor's degree or comparable) outside the European Union must now prove that they have passed the Graduate Management Admission Test (GMAT) with a score of 550 or better or the Graduate Record Examination Test (GRE) with a score of 300 or better. The score report must be submitted at the time of application.</p> <p>In addition to the existing Academic Evaluation Offices in China and Vietnam, the Academic Evaluation Office India (APS) has been established. All prospective students with educational certificates acquired in India must already submit a so-called APS certificate at the time of application!</p>

Please note that this is a consecutive Master of Science programme.

Proof of prior knowledge in the following:

- English, German and French language skills (details see below)
- Proof of further foreign language skills (if applicable)
- Proof of study or work abroad experience other than those gained in your home country (if applicable)
- Proof of programme-related work experience or internships (if applicable)
- Proof of voluntary work (if applicable)

You must also submit a strong one-page statement of purpose essay (written either in German or in English) on why you apply to this specific programme, including how this programme fits with your long-term goals. Specific questions to guide the essay are asked during the application process.

Number of places

Number of places: five places in India and five places in France (including international students) With regard to the number of study places for foreign students (non-EU), we can offer international students up to 20% of the total number of study places.

Documents

- You must submit your Bachelor's degree, which must be formally equivalent to a German Bachelor's. If you are not sure whether your previous course of studies qualifies for your chosen degree programme at our university, you may check the anabin databank (www.anabin.de).
- Full CV
- GMAT score report, showing 550 points or better, alternatively: GER score report, showing 300 point or better (for applicants who obtained their first university degree outside the European Union)
- Original or certified true copy of your school leaving certificate as well as original or certified true copy of German, English, or French translations of the named certificates
- Submit your school leaving certificate with average grade. To convert the grade of your school into a German grade, we would need the official grading system of your school. Please prepare by uploading a copy of the official grading system.
- If applicable: university entrance examination certificate from your home country
- Applicants who have completed previous periods of study in China, Vietnam, India, or Mongolia: APS certificate
- Original or certified true copy of your university leaving certificate (Bachelor's degree or equivalent) as well as original or certified true copy of German, English, or French translations of the named certificates
- You must submit full transcripts of your Bachelor's studies. Your transcript should show the average grade of your university degree. To convert this grade into a German grade, we would need the official grading system of your university. Please prepare by uploading a copy of the official grading system.

Language requirements

- English (level B2; e.g. by TOEFL score of 78 or better; Bachelor's or Master's degree in English – confirmation of university required)
- German (level A2 must be achieved by the end of the second semester of the programme at the latest; registration is conditional until then)
- Proof of French skills on level A2 or better for applicants who wish to study at the Toulouse Business School (French skills are not required upon application. However, level A2 must be achieved by the end of the second semester of the programme at the latest. Registration is conditional until then.)

Proof of the German and, if applicable, French language skills must be provided by the end of the second semester at the latest.

Possibility of finding part-time employment

It is possible to find a job as a student assistant ("Hiwi") by contacting professors and university departments directly. Information on current job vacancies can also be found on the website of each chair.
